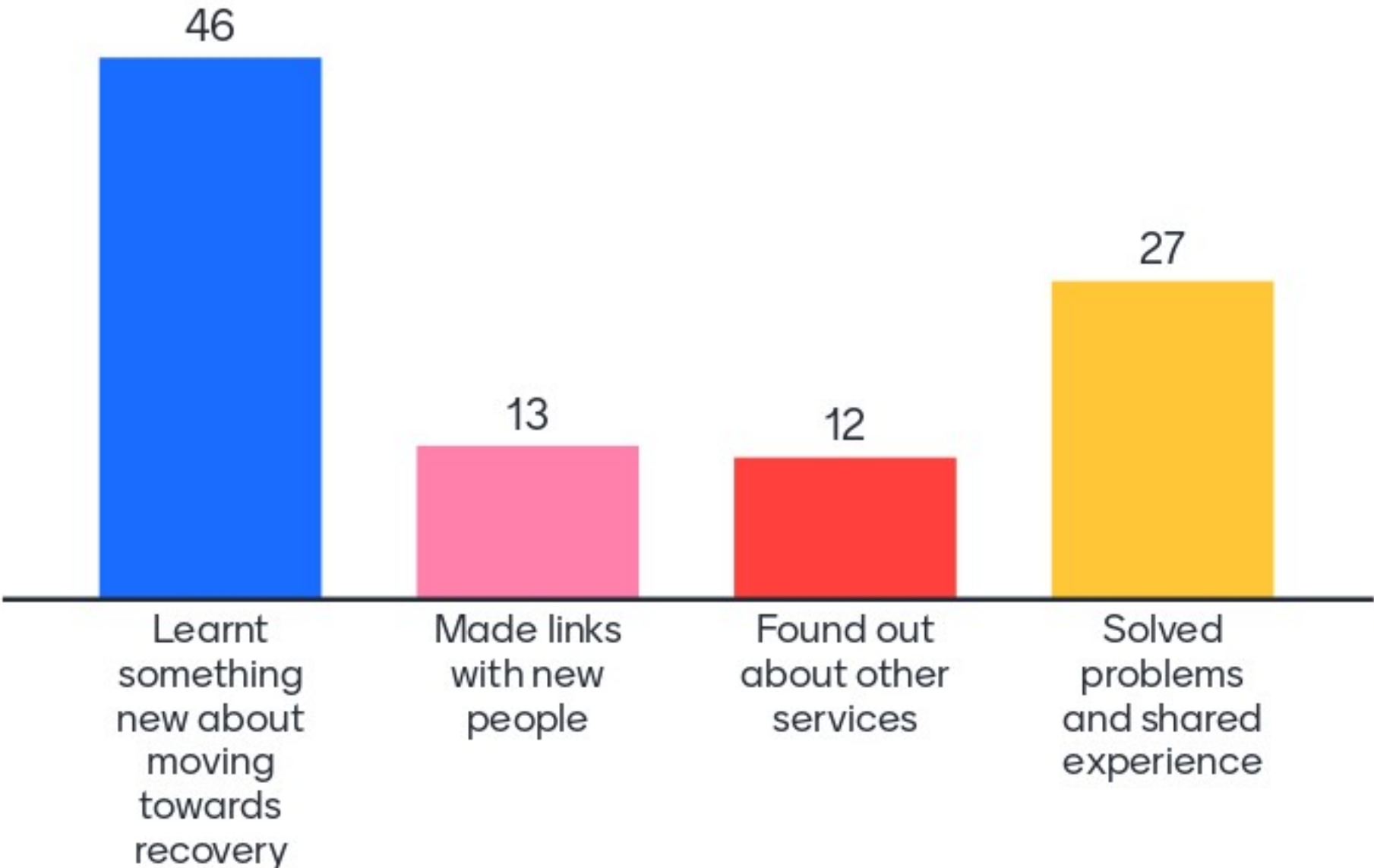


What was the outcome for you from today's session?

Have more confidence about the protocols needed for opening

Nothing Will recommend to fellow trustees we remain closed for the foreseeable future.

Add the COVID-19 Secure notice to the building entrances

Ensure a designated isolation area is established.

Rethink the chairs!

Will review risk assessment in light of latest info

Set up the emergency box.

Reopen for fitness classes Know what we can use for cleaning

Contact hirers for their expected return

What will you now do that you couldn't do or haven't done before this session?

Cleaning info helpful

Risk assessment has been completed but will now review i.e. hand dryers can now be used.

We have a Committee meeting on Monday to discuss reopening- this is very helpful

Convince others in the leadership of my church that the measures I've been recommending are wise and timely. Buy a steamer. Set up new systems for quarantining chairs. Plan carefully for the opening of the halls in due course.

Pass on learning to mgt committee tomorrow

Separate space for COVID suspected person. Box of PooOwn yoga mats

Clean in the correct way. Purchase s

Share with colleagues. Prepare the COVID box. Search for providers of PPE

compare notes with another similar activity and reassess risk assessment to hopefully be in a position to re-open sooner.

understand our responsibilities v resp of the hirer

Know how to measure the capacity of a room. Feel more confident about carrying out the risk assessment

Share with committee

Check ACRE information

Source anti-viral cleaner or white wine vinegar! Offer positive answers to our cleaning staff. Rotate furniture. Decide on isolation policy and staffing during classes. Alert insurance company of our proposed opening date (September)
