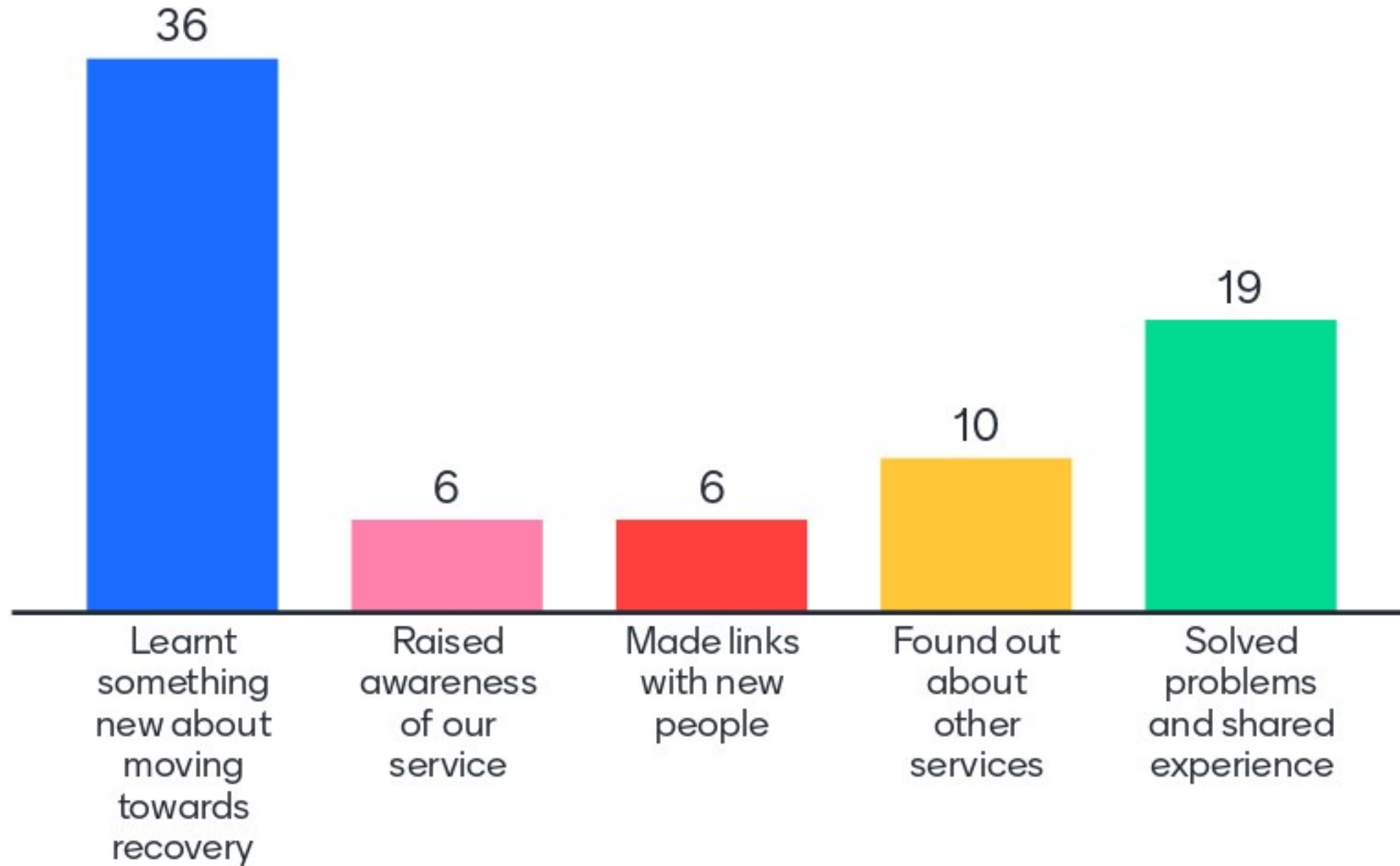


What did you achieve at today's meeting?

Preparation of risk assessment

A 5 stage recovery plan for our organisation would be very useful

Finishing risk assessments. Opening centre and have learned some good ideas on how to welcome back service users and volunteers

To discuss at the next board meeting date of re opening and key planning decisions that need to be implemented. Some key issues were helpfully raised today.

Review assess risk

Discuss with volunteers next steps to reopening service. Risk assessments to do.

Complete a draft risk assessment and share with all the volunteers before we come to an agreement regarding opening the building

Draw up a draft recovery plan with staff and trustees and then consult with volunteers and members.



As a result of this meeting, what are the next steps your organisation will take?

Feedback to Trustees tonight and chat to orchestra conductors and leaders. Other trustees have attended specific updates re musical organisations. Liaise with church hall for risk assessments. Thank you Very useful.

Pursue opportunities to diversify. Review communication strategy.

As part of a local authority, I am considering how we are best placed to support the local community in their recovery - whether that is practical support, financial support or simply advocating on their behalf

Risk assessment as regards the building, communication to members.

Will talk to Committee first and then share ideas with staff and volunteers on how to move forward. - in consultation with users
